**Secretary's Report:** Mike Morris distributed the May 5 minutes. After discussion and review the minutes were unanimously approved by voice vote.

**Treasurer's Report:** Frank stated there were no changes from the previous month's report. After discussion and review the minutes were unanimously approved by voice vote.

**Membership Report:** Bob Dawkins will start working on membership renewals for the 52 current BOS members. The membership year runs from July 1 to June 30. Bob received a letter from Mary Bouchard stating a she will make another donation to BOS. Ms. Bouchard has been very generous to BOS in the past. Mike reported that anyone can now give money to BOS via Paypal on the BOS Membership web site page to pay for a new membership, a membership renewal or an additional donation to BOS.

**Stewardship Report:** Ken reported more instances of dumping and shooting at the end of Woodhill-Hooksett Road on the Bow Bog Road side. The Bow Police asked for replacement signs due to vandalism of the existing signs. Stone Sled is expanding with 12 new units. Ken and Bob Lux will monitor the boundaries of the conserved land surrounding this new construction. Ken will sign the tree line and ask the Stone Sled owners' association to pay for sighting the property line by Ron Klemarczyk.

**Public Relations:** Martin could not attend the meeting. The BOS Spring newsletter was published on May 10.

Again it was noted that BOS is available for high school students who might be looking for a mutually useful project.

**Trail Report:** Hilary could not attend the meeting, but submitted the following update via email: "we are approved for the trails grant....work can start after 6/30. I have visited 3 of the 5 landowners who abut the Robinson Road Trail head area and told them about the planned parking lot improvements. They were all very friendly and OK with what I told them. I will visit the other 2 when we get back." Bob Dawkins reported completing trail maintenance on a large portion of the NCF trails.
